

SUPPLEMENT 2: **NON-COMMERCIAL** ITEM PROCUREMENTS U.S. GOVERNMENT CONTRACT PROVISIONS FOR NON-COMMERCIAL ITEMS

The clauses in Section 52 of the FAR and the DFARS herein below set forth and in effect on the date of this Order are each incorporated herein by this reference and made a part of this Order. In all such clauses, the term "Contractor" shall mean "Seller," the term "Contract" shall mean this "Order," and the term "Government Contracting Officer" or equivalent phrases, shall mean "Buyer" as applicable; except that in those clauses conferring patent and data rights to the Government, the term "Government" or "Contracting Officer" retains its literal meaning and is not to be construed as "Buyer." It is intended that the FAR and DFARS clauses as listed herein shall apply to Seller in such manner as is necessary to reflect the position of Seller as a subcontractor to Buyer, to ensure Seller's obligations to Buyer and to the Government, and to enable Buyer to meet its obligations under its Prime Contract or

subcontract. Clauses that are not applicable are self-deleting.
